# 15 YEAR PLUNGE POOL WARRANTY

## Terms of warranty:

ALPS Manufacturing, Inc. warrants to the original retail purchaser that if a Plunge Pool should suffer a structural failure due to a defect in material or workmanship within five (15) years from date of purchase, ALPS Manufacturing, Inc. will, at its option repair or provide a replacement Plunge Pool. The replacement Plunge Pool will be FOB our plant. The repair or replacement will be made in a timely manner, and either will be at no-charge to the original retail purchaser with the following exclusions:

ALPS Manufacturing, Inc. will not be responsible for the cost of removal or installation of any defective Plunge Pool, or any other costs, expenses or damages, including, but not limited to, freight, labor, concrete, water, chemicals, or landscaping.

Specifically excluded from this warranty is ordinary wear and tear, or defects caused by negligence, improper installation and/or improper use or maintenance. Failure to correctly follow installation instructions voids this warranty. Also excluded are damages caused by acts of God, accident, fire, mechanical or chemical means.

The warranty period of a repaired or replaced defective Plunge Pool shall extend only until the end of the original warranty period.

Return of warranty card within 30 days of purchase or valid proof of purchase is required to validate this warranty.

ALPS Manufacturing, Inc. shall not be liable for any consequential or incidental damages, including but not limited to any damages for loss of use or injury to persons or property. Any claims therefore are hereby specifically excluded. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights and you may also have other rights which may vary according to jurisdiction.

It is expressly agreed that there are no warranties expressed or implied, made by the manufacturer or their representatives or customers except as stated above.
